• Continuing Education

- o Continue ISHA Convention every other year, but not during IMASH years.
- o Awards (to be offered at Convention)-Past President to investigate what awards to offer by August 19 board meeting (Marcia will reach out to Anne).
- The Director of Audiology and the Director of Speech will investigate scholarships to be awarded at Convention for students by August 19 board meeting.
- The Convention Committee will explore the establishment of a central, online storage for all documents (when will this be completed by?).
- The Convention Committee will make recommendations to the Board on distance learning opportunities for Convention by March, 2018.
- Discuss at the August board meeting the development of a membership survey to see why members are or aren't members of ISHA and what they like or don't like about Convention.
- The President Elect will explore webinar topics for 2017 and beyond by January,
 2017 (Eileen Crowe at ASHA to put them in touch with the Past President of the
 Oregon SLH Association to discuss what they did).

• Website

- The President will speak to the ISHA Web Master by August 19 to discuss time frames for completing web updates. Follow up will then occur with the ISHA administrative staff to see what transition need to be made regarding these responsibilities.
- Once the Web Master responsibilities are determined, Eileen Crowe will schedule a conference call with the Web Master, the Secretary, and the President, and Tom Jelen at ASHA to discuss web functioning.
